Emissions reduction targets

In order to continue our progress to achieving Net Zero, Cloudera has partnered with <u>Watershed</u> to comprehensively measure our carbon footprint.

Our measurement process uses an operational boundary approach in accordance with the Greenhouse Gas Protocol on corporate accounting & reporting, and includes a comprehensive Scope 1, Scope 2, and Scope 3 evaluation using both primary activity data as well as spend based emission factors.

We project that carbon emissions will decrease by 26% over the next five years.

Carbon Reduction Projects

Completed Carbon Reduction Initiatives

The following environmental management measures and projects have been completed or implemented since the 2022 baseline.

- Participate in efforts to improve environmental protection and the sharing of appropriate knowledge, methods and working practices;
- Manage the consumption of energy, water, paper and other resources used by Cloudera in day-to-day operations;
- Identify opportunities to divert, minimize, reuse and recycle our waste stream;
- Incorporate environmental considerations into procurement processes;
- Consider environmental issues when leasing or purchasing property;
- Promote staff adoption of alternative and sustainable commuter transport options;
- Strive to reduce business travel and promote alternatives wherever practicable;
- Commit to complying with applicable environmental laws and regulations;
- Educate our employees about the steps Cloudera is taking to help protect the environment and providing channels for employees to contribute to our efforts; and
- Provide a space for employees to report any instances of noncompliance with applicable environmental laws and regulations and conduct appropriate follow-up.

The carbon emission reduction achieved by these schemes equate to 41 tCO $_2$ e, a 58.0% reduction against the 2022 baseline and the measures will be in effect when performing the contract.
